MINUTES OF 100TH MEPCO B.O.D. MEETING, HELD ON 28.01.2015 (WEDNESDAY) IN MEPCO CONFEREENCE ROOM KHANEWAL ROAD MULTAN

The Meeting started with recitation from the **Holy Quran** and gracious name of **Almighty Allah**. The Company Secretary intimated the Board about the "Leave of Absence" received from Mr. Sohail Akbar Shah & Mr. Muneer Ahmed, Honorable Members of MEPCO Board. The Board, after due consideration, granted the leave of absence to the honorable Members.

AGENDA ITEM NO.1

To consider and confirm Minutes of previous Board Meeting.

The Company Secretary presented the Minutes of 98th Board Meeting, the Board confirmed the Minutes of 99th Board Meeting.

AGENDA ITEM NO.2

Compliance of the instructions issued by the MEPCO Board in the previous BOD Meetings.

a) Regarding Ministry of Water and Power's initiative for selection of CEO MEPCO and Stay Order issued against the process initiated to appoint CEO MEPCO by the Honorable High Court Bench Multan, the Board was apprised that the case was fixed for hearing on 15-01-2015. Rao Muhammad Iqbal, Advocate Supreme Court of Pakistan was engaged on behalf of respondents. The engaged counsel has informed that the Honorable Lahore High Court Bench at Multan relisted the case and date is in office. He has given legal opinion that the interim order passed by Honorable Lahore High Court Bench at Multan dated 5-12-2014 "the process initiated in pursuance of the publication to appoint the Chief Executive Officer MEPCO is stayed till next date of hearing" is still in field, intact, operative binding effect. The Members pointed out that although the Ministry of Water and Power had relaxed the maximum age criteria set in the advertisement and a list of 195 applications have been received, but many capable engineers have failed to apply due to non communication of the aforesaid relaxation of maximum age limit well in time. The Members opined that on the analogy of NTDC, an advertisement should be given in leading newspapers so that those engineers can also apply for the post of CEO MEPCO. The Board was further apprised that a legal opinion was sought from Manager (Legal & labor) MEPCO who has clarified that the Honorable Court has not restricted Honorable BOD MEPCO for fresh advertisement/publication, so such act on behalf of BOD MEPCO will not caused prejudice the interim order and also will not amounts to the contempt of the Honorable High Court Orders. The

- Board resolved that a fresh advertisement for appointment of CEO MEPCO under intimation to Ministry of Water and Power be published on the analogy of NTDC.
- b) Regarding the issue of terminated employees who were recruited during 2009-10 and 2012-13, the Board was apprised that HR Committee of the Board was given detailed presentation by HR & Admn Director. The Committee informed the Board that Company has complied with the orders/instructions of the Honorable Courts issued from time to time. The Committee has further recommended that the Government rules be followed as company is conducting recruitments through NTS, however, experience gained by the terminated employees during their service may be given sympathetic consideration. The Board approved the recommendations of the HR Committee of the Board.
- c) The Inquiry Committee constituted by the Board to probe into the matter regarding recovery of detection bill amounting to Rs. 117.68 Million in respect of Colony Textile Mills intimated the Board that meetings of Inquiry Committee could not be held due to non availability of the representative of Colony Textile Mills. The Board instructed the Inquiry Committee to decide the matter at earliest and progress be intimated to the Board in next Meeting.
- d) Regarding deposit/ enhancement of maximum deposit limit for M/s First Women Bank Ltd. and opening of Retention Account with M/s Silk Bank Ltd. the Board was informed that the case was referred to Audit Committee of the Board but the meeting could not be held due to absence of quorum. Mr. Khalid Masood Khan, Member Board showed his displeasure for not holding of the Meeting for two months. The Honorable Member was apprised that consent of the Members of the Committee was obtained twice for holding of the meeting but the same could not be held only due to non availability of the Members. The Board desired that meeting be held at earliest to decide the issue. The Members of the Audit Committee decided to hold the meeting on 30-01-2015. The progress achieved in this regard was instructed to be presented in next Meeting.
- e) The Finance Director apprised the Board that Privatization Commission Board in its meeting held on 22-07-2014 has approved the appointment of Financial Advisors for the divestment of Government of Pakistan shareholding in MEPCO. The Draft TORs for procurement of financial advisory services were received for comments/views. A meeting was scheduled in the Committee Room of the Privatization Commission on 27-01-2015 to finalize the draft of TORs in consultation with the stakeholders. The comments were submitted to the Director General (A & F) Privatization Commission subject to approval of the Board of Directors of MEPCO. The comments upon draft TORs were presented to the Board for its deliberation. The Board authorized the Audit Committee for detailed discussion/deliberation upon the comments.

AGENDA ITEM NO.3

To confirm the Circular Resolution No. 51 dated 31.12.2014.

The Board was intimated that the matter for procurement of 1000 No. 200 kva Distribution Transformers (T/No. 26) on urgent basis was presented to the Members of the Board. After considering the matter, the Board passed the below detailed Circular Resolution.

"Resolved that approval be and is hereby accorded for procurement of 1000 No. 200 kva Dist: Transformers @ Rs. 425000/- each from M/s PEL as lowest bidder technically on TOC basis for the full tendered quantity. The total cost of procurement would be amounting to Rs. 497.250 million (including 17% GST) against Tender No.26.

Further resolved that approval be and is hereby accorded for the procurement of offered 500 No. 200 kva Dist: Transformers against Tender No. 82 and offered 500 No. 200 kva Dist: Transformers against Tender No. 90 from M/s Transfo Power being lowest bidder in both tenders, if the firm reduces its quoted rates i.e Rs 4, 35,000/- per unit to Rs.4, 25000/- per unit".

It was further stated that in response of above M/s Transfo Power Ind offered the revise rate Rs. 435000/- to Rs. 425000/- against the said tenders. They further submitted that the above rates valid only if the delivery period of the 2nd tender No. 90 is commenced from the expiry of the tender No. 82. According to this the delivery schedule of 2nd tender quantity will start after 90 days (after completing 1st tender quantity). The procurement committee of the Board has also agreed with the above narrated delivery schedule of 2nd tender quantity. The Board was requested to confirm the above Circular Resolution along with above mentioned delivery schedule of 2nd tender quantity.



Decision

The Board resolved that the above Circular Resolution be and is hereby confirmed above with above narrated delivery schedule for 2nd tender quantity.

AGENDA ITEM NO.4

To confirm the Circular Resolution No. 01 dated 02.01.2015.

The Board was informed that the matter for renewal of Power Purchase Agreement for purchase of 2.5-MW Bagasse Based Power offered by M/s Hamza Sugar Mills Ltd (HSML) located at Jetha Bhutta Khan Pur District R.Y.Khan.on urgent basis was presented to the Members of the Board. After considering the matter, the Board passed the below detailed Circular Resolution.

"Resolved that approval be and is hereby accorded for renewal of Power Purchase Agreement (PPA) for purchase of 2.5 MW bagasse based power from M/s Hamza Sugar Mills Ltd. (HSML) w.e.f. 05.01.2015 to 04.01.2016 (one year) along with metering at 132 KV Grid Station Feroza and to allow connectivity and metering on previous power dispersal arrangement for crushing season 2014-15 till the completion of 11KV feeder".

Board was requested to confirm the above Circular Resolution.

Decision

The Board resolved that the above Circular Resolution be and is hereby confirmed.

AGENDA ITEM NO.5

To confirm Resolution No.02/2015 dated 13.0.1.2015

The Board was informed the matter regarding design of external electrification of "Agrics Cooperative" Housing Scheme situated at Mouza Neel Kot, Multan, on urgent basis was presented to the Members of the Board. After considering the matter, the Board passed the below detailed Circular Resolution.

"Resolved that administrative approval be and is hereby accorded for the estimate for external electrification of "Agrics Co-operative" Housing Scheme situated at Mouza Neel Kot, Multan amounting to Rs. 24.355 Million (Electrification Cost Rs. 21.143 Million , Grid Sharing Cost Rs. 3.212 Million & Design Vetting Charges Rs. 0.317 Million)."

The Board was requested to confirm the above Circular Resolution.

Decision

The Board resolved that the above Circular Resolution be and is hereby confirmed.

AGENDA ITEM NO.6

Approval for maximum upper limit of daily allowance up to 10- days

The Board was apprised that Chairman WAPDA in a meeting with All Chief Executive Officers held on 22-23.11.1999 fixed maximum upper limit for Daily Allowance up to 10-days for any officer/official. However, Chief Executive Officer is competent to allow Daily Allowance beyond 10-days. Later on, due to drastic reduction in MEPCO budget for financial year 2010-2011, the office of HR & Admn Director with the approval of Chief Executive Officer MEPCO took many austerity measures including reduction in maximum limit of 10-dailies to 08-dailies till Jan-2011. Since then, no further instructions have been issued in this regard. Presently, CBA / Union is pressing hard to enhance the upper limit of dailies up to 10-days as per previous orders of Chairman WAPDA dated 23.11.1999 with the plea that due to 30% deficiency of staff, MEPCO employees have to move frequently in the field/ far flung areas in order to maintain efficient Distribution System and for Customer Care. It is added that due to hard work and extraordinary efforts by the staff, target of 100% recovery has already be achieved along with reduction in line losses. The Board was requested to accord approval for enhancing maximum upper limit for Daily Allowance up to 10-days for field staff keeping in view the acute shortage of staff with immediate effect. The Board was further apprised that the case was presented to the HR committee of the Board. The Committee has recommended the case for Board's approval with the recommendations to approve enhancement in maximum upper limit for Daily Allowance up to 10 days for field staff keeping in view the acute shortage of staff with immediate effect, however, the enhancement will be reversed once the shortage is overcome with recent recruitments being carried out by the Company. The Board agreed with the recommendations of the HR Committee of the Board.

Decision

The Board accorded approval for enhancing maximum upper limit for Daily Allowance up to 10 days for field staff keeping in view the acute shortage of staff with immediate effect, however, the enhancement will be reversed once the shortage is overcome with recent recruitments being carried out by the Company as recommended by the HR Committee of the Board.

AGENDA ITEM NO.7

Approval for amendment in section 19(a) of leave rules/encashment of up to 365x days leaves in of LPR.

The Board was informed that Assistant Manager (Admn) PEPCO conveyed approval of Managing Director PEPCO vide office memo No.GM(HR)/HRD/A-332/182-210 dated: 22.01.2014 regarding amendments in Section 19(a) of Standing Rules w.e.f. 01.07.2012 as follows: -

"In the said Rules, the words one hundred and eighty are substituted with the words three hundred and sixty five".

The Existing Section 19(a) Pakistan WAPDA Leave Rules-1978 is as under: -

"In case of WAPDA employee dies or is declared permanently incapacitated for further service by a Medical Board (constituted by the Director General Medical Services under Rules-17 of the Pakistan WAPDA Employees Medical Attendant Rule-1979) while in service, a lump sum payment equal to leave pay upto one hundred and eighty days out of the leave at this credit shall be made by the head of office to his family as defined for the purpose of family pension or as the case may be to the WAPDA employee".

The Board was further apprised that HR committee of the Board has also recommended the case for Board's approval. The Board was requested to accord approval for adoption Authority's office memorandum No. GM(HR)/HRD/A-332/182-210 dated 22.01.2014 regarding amendment in Section 19(a) Pakistan WAPDA Leave Rules to substitute the words "one hundred and eighty" with the words "three hundred and sixty five" in the interest of work.

Decision

The Board accorded its approval for adoption Authority's office memorandum No. GM(HR)/HRD/A-332/182-210 dated 22.01.2014 regarding amendment in Section 19(a) Pakistan WAPDA Leave Rules to substitute the words "one hundred and eighty" with the words "three hundred and sixty five" in the interest of work.

AGENDA ITEM NO.8

Approval for creation of post for MEPCO Colony Farooq Pura Multan under Manager (Civil) Division Multan.

The Board was informed that Manager Civil Division MEPCO Multan recommended creation of 02 No. posts for security/ maintenance of MEPCO Colony Farooq Pura Multan. It was also apprised that the offices of XEN T&G, SDO (Op) Sub Division Wallayat Abad & SDO (Op) Sub Division Industrial Estate are located in MEPCO Colony Farooq Pura Multan. Moreover 10 No. residences for officers / officials are also situated in the MEPCO Colony Farooq Pura and no post of Security Guard & Mali is sanctioned for safety of the premises and to look after the colony. Accordingly, the case was examined by MEPCO Scrutiny Committee held on 21.11.2014 which has recommended creation of 01 No post of Security Guard and 01 No. post of Mali for security and to look after the premises / MEPCO colony Farooq Pura Multan. The Board was further apprised that the case was presented to the HR committee of the Board. The Committee had authorized Khawaja Muhammad Azam and Mr. Zahid Perveiz Marral Honorable Members of the Committee to decide the case after visiting the above said MEPCO Colony. The Members apprised the Board that they had visited the above said Colony and recommended the Board to accord its approval for creation of 1 No post of Security Guard & 1 No. post of Mali at MEPCO colony Farooq Pura as recommended by MEPCO scrutiny committee in the interest of work.

Decision

The Board accorded its approval for creation of 1 No post of Security Guard & 1 No. post of Mali at MEPCO colony Farooq Pura as recommended by MEPCO scrutiny committee in the interest of work.



AGENDA ITEM NO.9

Approval for creation of (Op) Sub Division Taunsa after bifurcation of existing Sub Division Taunsa City.

The Board was informed that Superintending Engineer (OP) MEPCO Circle D.G. Khan recommended bifurcation of existing operation Sub Division Taunsa City and creation of (OP) Sub Division Rural Taunsa. The existing (OP) Sub Division Taunsa is the biggest / heaviest sub Division under XEN (Op) Division Taunsa having very vast area. SDO (OP) Sub Division Taunsa is unable to look after the work properly due to rapid increase in number of connections day by day. The proposed (OP) Sub Division Rural Taunsa will consist upon mostly Rural areas whereas presently modified (OP) Sub Division Taunsa will have urban areas. Existing Taunsa Sub Division is working beyond the permissible limit of number of connections. It is necessary to create another Sub Division to minimize the losses and to increase the recovery progress. Work load of Taunsa Sub Division will be divided by reducing number of consumers and length of HT-Lines. The creation of new operation Sub Division Rural Taunsa will surely promote the receipt of resources of MEPCO and will also redress public complaints. Accordingly the case was examined by the MEPCO scrutiny committee on 21.11.2014 which has recommended the creation of Sub Division Rural Taunsa after bifurcation of existing (OP) Sub Division Taunsa. The Board was further apprised that HR committee of the Board has also recommended the case for Board's approval. The Board was requested to accord its approval for creation of (OP) Sub Division Rural Taunsa after bifurcation of existing (OP) Sub Division Taunsa as recommended by MEPCO scrutiny committee in the interest of work.

Decision

The Board accorded approval for creation of (OP) Sub Division Rural Taunsa after bifurcation of existing (OP) Sub Division Taunsa as recommended by MEPCO scrutiny committee in the interest of work.

AGENA ITEM NO.10

Approval for creation of (Op) Sub Division Tibbi Qaisrani after bifurcation of existing Sub Division Vehova.

The Board was intimated that Superintending Engineer (OP) MEPCO Circle D.G.Khan recommended bifurcation of existing operation Sub Division vehova and creation of (OP) Sub Division Tibbi Qaisrani. The existing (OP) Sub Division vehova is the biggest / heaviest operation Sub Division under (OP) Division Taunsa having very vast area. SDO (OP) Sub Division vehova is unable to look after the work properly due to rapid increase in number of connections day by day. The proposed (OP) Sub Division Tibbi Qaisrani and presently modified (OP) Sub Division vehova will consist upon rural areas. Vehvoa Sub Division is working beyond the permissible limit of number of connections. It is necessary to create another Sub Division to minimize the losses and to increase the recovery progress. The work load of Vehvoa Sub Division will be divided by reducing the number of consumers and length of HT-Lines. The creation of new operation Sub Division Tibbi Qaisrani will surely promote the receipt of resources of MEPCO and will also redress public complaints. Accordingly the case was examined by the MEPCO scrutiny committee on 21.11.2014 which has recommended the creation of Sub Division Tibbi Qaisrani after bifurcation of existing (OP) Sub Division Taunsa. The Board was further apprised that HR committee of the Board has also recommended the case for Board's approval. The Board was requested to accord approval for creation of (OP) Sub Division Tibbi Qaisrani after bifurcation of existing (OP) Sub Division Vehova as recommended by MEPCO scrutiny committee in the interest of work.

Decision

The Board accorded approval for creation of (OP) Sub Division Tibbi Qaisrani after bifurcation of existing (OP) Sub Division Vehova as recommended by MEPCO scrutiny committee in the interest of work.

AGENDA ITEM NO.11

Approval for grant of Honorarium/Bonus to the Employees of MEPCO

The Board was informed that the Honorable Minister of State for Water & Power, Govt. of Pakistan, Islamabad during his visit to MEPCO on 23.12.2014 has announced the grant of Honorarium/ Bonus equal to one month basic pay to MEPCO employees on account of their hard work, dedication and

extra ordinary efforts which helped the company in giving outstanding performance. The Company has achieved target of 100% recovery in first five months. The company has also earned profit worth Rs. 8.547 Billion approximately for the months from July to November-2014. The Ministry of Water & Power also forwarded 02 No. lists of 54-employees of its Secretariat with the recommendation to also allow them honorarium on account of their hard work and dedications for contribution towards the performance of Company. The Board was further apprised that the case was presented to the HR committee of the Board. The Committee was requested to recommend the case for Board's approval for grant Honorarium / Bonus to MEPCO employees with its distribution as under:-

- One month running basic pay to all regular employees of MEPCO including MEPCO staff deputed to work in WAPDA Hospital Multan.
- ii. One month basic pay to all contractual employees working against regular posts.
- iii. One month pay to all daily wages employees (to be calculated on the basis of working days of the previous month).
- iv. 54 Nos. employees of Ministry of Water & Power amounting to Rs.9,21,700/-

The Committee has recommended for grant of Bonus/Honorarium first 3 categories as requested, however, the Committee desired to reduce the Secretariat staff of Ministry of Water & Power on proportionate basis as per share of MEPCO amongst 9 DISCOs. The HR & Admn Director submitted a list of 20 No. Secretariat Staff in compliance of HR Committee's directions and requested the Board to accord its approval for grant of Bonus/Honorarium to 20 No. Secretariat Staff amounting to Rs. 363500/- as per list presented to the Board. The Board agreed with the request with the instructions to pay the amount of Rs. 363500/- to 20 No. Secretariat Staff from some other account head rather than from salary account head.

Decision

The Board accorded approval for grant of Honorarium / Bonus to MEPCO employees with its distribution as under:-

- i. One month running basic pay to all regular employees of MEPCO including MEPCO staff deputed to work in WAPDA Hospital Multan.
- ii. One month basic pay to all contractual employees working against regular posts.
- iii. One month pay to all daily wages employees (to be calculated on the basis of working days of the previous month).

However, the payment of the amount of Rs. 363500/- to 20 No. Secretariat Staff from some other account head rather than from salary account head.

AGENDA ITEM NO.12

Approval for admissibility of pre-mature increment to the employees of BPS-01 to 04.

The Board was intimated that Deputy Director Finance (Reg.) office of Finance Division (Admn & Regulation) WAPDA House Lahore vide office order No: F.O(B&F)/10-126/Vol-39/3766-3865 dated 05.08.2014 has conveyed that the Authority has been pleased to accord approval to allow one pre-mature increment to the employees in BPS-01 to 04 w.e.f. 01.07.2014. This increment will not affect the normal annual increment due on 01.12.2014 if otherwise admissible under the Rules. The office of HR & Admn Director wrote a letter to General Manager (HR) PEPCO WAPDA House Lahore regarding clarification whether PEPCO has adopted / issued office order regarding admissibility of pre-mature increment to the employees of BPS-01 to 04. GM (HR) PEPCO vide letter dated: 09.09.2014 has informed that the subject matter is under process, the same will be communicated accordingly, as and when finalized. It was added that CBA Union is again and again pressing hard for implementation of office order No: F.O (B&F)/10-126/ Vol-39/3766-3865 dated: 05.08.2014. The Board was further apprised that HR committee of the Board has also recommended the case for Board's approval. The Board was requested to accord approval for adoption of above mentioned Finance Division (Admn & Regulation) WAPDA House Lahore office order for implementation in MEPCO.

Decision

The Board accorded approval for adoption of above mentioned Finance Division (Admn & Regulation) WAPDA House Lahore office order for implementation in MEPCO.

AGENDA ITEM NO.13

Approval for purchase of Mobile Set for CEO MEPCO.

The Board was informed that Dash Board is being maintained by Ministry of Water & Power Islamabad for monitoring the recoveries and other KPIs, load management etc. The data / information is shared continuously and messages are being received for various reports/ compliances. In order to meet this requirement, a sophisticated mobile phone set, having following specifications, is required for the official use of CEO MEPCO: -

- a. Capability of Large data storage
- b. Latest Operating Software
- c. Having 3G & 4G internet Facility
- d. Wifi Connectivity

Further, above mentioned specifications are available in "Apple iphone 6" which is available in local market for Rs.77000/-. As per Part III (2) of Revised Telephone Policy 2010, General Managers are entitled for purchase of mobile phone set up to Rs.10000/- on departmental expenditure. The Board was further apprised that HR committee of the Board has also recommended the case for Board's approval. The Board was requested to accord its approval for purchase of Mobile Phone Set (Make: Apple Model: iphone 6) @ Rs.77000/- (Rupees Seventy Seven Thousand only) for CEO MEPCO. The Board accorded its approval as requested for. At present there is no vehicle that could be used for VVIP Security Escort duty. Therefore a Toyota Double Cabin Vigo Champ may be purchased for the same purpose. However, as per Service Rules, the post of Gate Clerk is filled through 100% direct recruitment. The qualification of Store Helper and Gate Clerk is the same i.e. Matric 2nd Division. Most of the Store Helpers have more than ten years of service but have not been promoted since long due to non availability of promotion quota for the post of Gate Clerk. There are two way to redress their grievances either to consider them Class-IV employees or to fix 25% quota for promotion as Store Clerk in their own cadre by amending service rules. It is opined that more appropriate is to fix 25% quota for promotion as Store Clerk so that their previous experience may be utilized in their own cadre in the interest of work. In case they are treated as Class-IV employees, they may be considered for promotion as ALM / ASSA / Jr. Clerk / Helper M&T subject to their suitability, which will change their line of cadre and their previous experience, cannot be best utilized in new cadre. The Board was requested to accord approval for amending the service rules of Gate Clerk as 75% direct quota & 25% promotion quota (instead of 100% direct quota) for Store Helpers on seniority cum fitness basis in the interest of work. The Board was further apprised that HR committee of the Board has also recommended the case for Board's approval. The Board was requested to accord its approval for amending the service rules of Gate Clerk as 75% direct quota & 25% promotion quota (instead of 100% direct quota) for Store Helpers on seniority cum fitness basis in the interest of work.

Decision

The Board was informed that an amendment was made in the criteria for promotion of Graduate / Non-Graduate Junior Clerks (Finance Department) for their promotion as Accounts Assistant from MEPCO BOD in its 71st meeting held on 28.10.2010 vide Agenda Item No.14(G) Annex- A as per following detail:-

- i. 30 % by promotion from Graduate Junior Clerks on passing Departmental Promotion Examination & completion of promotion training after 03 years length of service on seniority cum fitness basis.
- ii. 10% by promotion of Junior Clerks with Matric / Intermediates on passing Departmental Promotion Examination & completion of promotion training after 10 years length of service on seniority cum fitness basis.

It was apprised that the original Quota for promotion of Non-Graduate Junior Clerks was 25% and the length of service was 03 years. This amendment of reduction in quota from 25% to 10% and increase in service length from 03 years to 10 years created unrest and agitation amongst the Non-Graduate Junior Clerks of Finance cadre. Accordingly, Finance Director MEPCO sought clarification from the office of Director Finance Regulation WAPDA House Lahore vide office Memo No. FDM/Admn-112/32825 dated 20/06/2014 and subsequently his office has clarified the promotion criteria for graduate as well as Non-Graduate Junior clerks (Finance Directorate) vide its Office letter No. FDP/MEPCO/705-08 dated 24.06.2014 as under:-

i) Graduate Junior Clerk

15% After passing DPE & Training.

ii)Non-Graduate Junior Clerk

25% After passing DPE & Training

CBA union as well as Finance Directorate is stressing hard to restore the original criteria for promotion of Graduate/ Non-Graduate Junior Clerks (Finance Directorate) as per clarification of Finance Regulation WAPDA House Lahore to create harmony amongst the employees of said cadre. The committee was requested to recommend the case to the Board for its approval to withdraw its amendment made in the service rules for promotion of Graduate / Non-Graduate Junior Clerks (Finance Directorate) in its 71st meeting held on 28.10.2010 vide Agenda Item No.14(G) and to restore the original criteria for their promotion as clarified by Director Finance Regulation WAPDA House Lahore as mentioned above in the interest of work. The Board was further apprised that HR committee of the Board has examined the case and has recommended to fix 05 years length of service to consider the promotion of eligible non graduate junior clerks (Finance department) to the next cadre as Account Assistant instead of 3 years. The Board was requested to accord its approval for fixation of 05 years length of service to consider the promotion of eligible non graduate junior clerks (Finance department) to the next cadre as Account Assistant as recommended by the HR Committee of the Board.

Decision

The Board accorded its approval for fixation of 05 years length of service to consider the promotion of eligible non graduate junior clerks (Finance department) to the next cadre as Account Assistant.

Approval for grant of 04 advance increments on account of meritorious performance in respect of Malik Ameer Abbas Dy. Manager (Legal & Labor) MEPCO HQ Multan.

The Board was intimated that Malik Ameer Abbas, Dy: Manager (Legal) MEPCO H/Q Multan has been nominated as "Best Performer" from the Head Quarter Employees, as he has devotedly performed his duties that have contributed a lot towards achievement of organizational objectives / goals. He being a Team Member played a vital role through his following outstanding performance:-

- 1. Due to the prompt monitoring of the court cases and proper legal assistance to the engaged counsel, 220 No. cases have been decided in favor of MEPCO in respect of "Billing Matters", 149 No. cases in respect of "Service Matters" and 395 No. service cases pertaining to MEPCO officials before Honorable High Court Benches. The overall detail of winning percentage of above named officer is 90%.
- 2. More than 350 No. terminated employees filed writ petitions before the Honorable High Court and these writ petitions were decided in favor of terminated employees. On the recommendation of



Dy: Manager (Legal), competent authority accorded approval to file Intra Court appeal before Honorable Divisional Bench of the Lahore High Court Multan and Department won the case and Honorable High Court upheld the termination orders dated 05.07.2013 passed by the Department. Due to this, Department has saved millions of rupees in shape of back benefits etc.

The Board was intimated that as per PEPCO Organogram, 01 No. post of Assistant Manager is sanctioned at each Operation Circle. Out of 08 No. Operation Circles, 05 Nos. Posts have been activated so far. The Administrative & Ministerial work is increasing day by day due to challenging environment which needs quick decision making and disposal of work. In order to improve the efficiency of working at Circle level, MEPCO has advertised the remaining 03 No. posts of Assistant Manager (Admn/ HR) in Daily News Papers (Jang, Khabrain & Nawai-e-waqt) on 11.01.2015 to fill up the vacancies falling under direct quota in the interest of Company. The Board was further apprised that HR committee of the Board has also recommended the case for Board's approval. The Board was requested to accord approval for activate remaining 03 No. posts of Assistant Manager (Admn/HR) at 03 No. Operation Circles i.e M/Garh, R.Y. Khan & Vehari, so that eligible candidates (on merit) may be recruited against direct quota through NTS in the interest of work.

Decision

The Board accorded its approval for activation of remaining 03 No. posts of Assistant Manager (Admn/HR) at 03 No. Operation Circles i.e M/Garh, R.Y. Khan & Vehari as proposed.

AGENDA ITEM NO.22

Approval for transfer of Rs.55 Million to WAPDA on account of Lease Amount Collected by MEPCO of WAPDA Land.

The Board was informed that the system of Head Sidhnai was constructed during 1960-61 by IBP-WAPDA (Water Wing Formation). 987.34 Acres land in 08 Mouzas of Khanewal District and 1164 Acres Land in 06 Mouzas of Vehari District was acquired by the WAPDA for construction of system up to Mailsi Siphon. On completion of one year maintenance, WAPDA handed over this entire system to Irrigation and Power Department Govt. of Punjab along-with colonies / rest house etc. Due to non transfer of land title by Irrigation and Power Department in Revenue record, said land ownership is still in the name of WAPDA. Military paid Rs.9,278,670/- to WAPDA during 1978-79 for purchase of Mailsi + Abdul Hakeem Land assets + colonies in which Rs.1,152,219/- was adjusted for thermal power and its colonies at Sukkur (17.06 Acres) which was constructed during 1960. The local Military formation has occupied much more land than its payment. To identify the issues of extra land occupied by Military, a Board comprising of Military + MEPCO Officer was constituted in 2001. Almost 107 Acres WAPDA Agriculture Land in Abdul Hakeem + Mian Channu was taken over by MEPCO as result of Board Proceedings which has been leased out annually. MEPCO collects Rs.7.75 Million todate as result of such annual leasing. Chief Engineer (Dams) WAPDA intimated that the matter is on the agenda of Public Accounts Committee. Chief Auditor WAPDA as well as Director General (Audit) Govt. of Pakistan both are pressing hard for transfer of lease amount collected by MEPCO to WAPDA (being custodian of land as per revenue record) and requested for the transfer of this amount in the account of WAPDA. In this regard a committee has been constituted by Chief Executive Officer MEPCO to settle the matter regarding transfer / recover of lease amount collected by MEPCO of

In present scenario when 220-KV Kassowal Grid Station is coming into circuit and existing 132-KV D/C Transmission Line Mian Channu – Chichawatni will be connected with IN/OUT at 220-KV Grid Station Kassowal. It will be better to connect Chak 83/12-L Grid Station from 132-KV Transmission Line Kassowal – Khanewal C-II by making IN/OUT arrangement at Chak 83/12-L Grid Station instead of 132-KV Grid Station Mianchannu. Comparison of above change is as under:-

The Board was informed that construction of 132-KV SDT Transmission Line Shadun Lund - Shah Sadar Din has been proposed in ADB-Tranche-III-MEPCO-03 Projects to feed for 132-KV Grid Station Shah Sadar Din due to conversion of 66-KV Grid Station to 132-KV level and the work for construction of same Transmission Line has been awarded to M/S ICC (Pvt) Ltd Lahore on turnkey basis. After going through the PC-1 of the subjected work as well as the contents of the contract agreement (signed between MEPCO and M/S ICC), it has been found that as per approved PC-I, the connecting point for feeding Transmission Line of Shah Sadar Din Grid Station (under conversion) is from 132-KV Grid Station DG Khan-II. The PSS-E studies have already carried out by the P&E Department while preparing the said PC-1 therefore if the work is carried out according to the approved PC-1 there is no need of studies but if it is carried out according to the contract agreement then a fresh PSS-E study will also be required. The Chief Executive Officer MEPCO Multan has recommended the most feasible and better feeding point to 132-KV Grid Station Shah Sadar Din is from 132-KV SDT Transmission Line DG Khan-II to Shah Sadar Din, due to upcoming 500/200-KV Grid Station DG Khan. Hydro Electric Workers Union (CBA) on 39th April, 2014. As per Point No.04 of the minutes of meeting, Honorable Minister has agreed to revise the compensation upon accidental death of an employee Rs.25,00,000/- as per rules / policy on the subject matter under intimation to Ministry. f. Approval for appointment of hafiz-e-quran as naib qasid/mali against employee's children

The Board was apprised that as per Director General (S&GA) Wapda House, Lahore office memorandum No.DG (S&GA)/D(Rules)/07453/30/III/56906-57206 dated 19.11.2003, the qualification for the post of Naib Qasid/Mali is Middle and ALM is Matric. Hafiz-e-Quran candidates are appointed as Sweeper by considering them as Literate. CBA Union during its meeting held with Chief Executive Officer on 24.01.2015 has demanded to appoint Hafiz-e-Quran (children of MEPCO employees) as ALM/Naib Qasid/Mali who died during service after 13.06.2006 & fatal/non fatal accident case, being a Muslim and having sanad of Hafiz-e-Quran. The Board was requested to accord approval to appoint Hafiz-e-Quran (children of MEPCO employees) as Naib Qasid/Mali who died during service after 13.06.2006 & fatal/non fatal accident case, being a Muslim by relaxing laid down qualification.

Decision

The Board accorded special approval for appointment of Hafiz-e-Quran (children of MEPCO employees) as Naib Qasid/Mali who died during service after 13.06.2006 & fatal/non fatal accident case, being a Muslim by relaxing laid down qualification.

g. Approval for estimate for connectivity for Purchase of 2.5 MW Bagas based power from M/S Hamza Sugar Mills Ltd. (HSML).

The Board was informed that an agreement was signed between MEPCO and M/s Humza Sugar Mills Ltd. for purchase of 2.5 MW bagas based power for a period of four years which can be extended by mutual consent. The PPA is going to expire on 04.01.2015. As per direction of Competent Authority a separate 11 kV line from HSML premises to 11 kV Bus Bar is to be constructed to avoid purchase of power at high loss 11 kV Feeder. The construction of proposed line is responsibility of MEPCO however HSML has agreed to provide interest free loan for said purpose. BOD in 98th meeting has accorded approved to accept the loan. Now, Project Director (Const) has prepared the estimate of connectivity amounting to Rs. 28,194,050/-. The Board was further informed that procurement committee of the Board has also recommended the case for Board's approval. The Board was requested for approval of estimate for connectivity for Purchase of 2.5 MW Bagas based power from M/S Hamza Sugar Mills Ltd. (HSML).

Decision

The Board accorded its administrative approval of estimate for connectivity amounting to Rs. 28,194,050/-for Purchase of 2.5 MW Bagas based power from M/S Hamza Sugar Mills Ltd. (HSML).

- ii. The Board resolved that Mr. Khalid Masood Khan Member Board be and is hereby appointed as Member of the Bid Evaluation Committee constituted during its 97th Meeting vide Agenda Item No 8.
- iii. MEPCO international players of Kabbadi, Handball, Hockey, Football, Taekwondo and Wrestling representing Pakistan at international level were also introduced to the Board. The performance and achievements of each individual player was communicated to the Board. The

Board appreciated the performances of the players, expressed that these players are the assets of the Company and hoped that the players would continue to perform well in the games in future as well. The Board resolved that honorarium amounting to Rs. 25000/- be awarded for each of 12 players as recognition to their achievements. Furthermore Chairman Board, Mr. Ahsan Rasheed, Mr. Rehman Naseem and Muhammad Anees Khawaja Members of the Board also announced for award of Rs. 10000/- for each player as acknowledgement of their performance at international level.
