# Formation of MEPCO Board's Committees

The agenda was presented by Company Secretary MEPCO. The Board was informed that according to Public Sector Companies (Corporate Governance) Rules 2013, Sections 12, the Board shall setup the following committees to support it in performing its functions efficiently and for seeking assistance in the decision making process, namely:-

- a) Audit Committee, for an efficient and effective internal and external financial reporting mechanism;
- b) Risk Management Committee, in case of Public Sector Companies either in the financial sector or those having assets of five billion rupees or more, to effectively review the risk functions;
- c) Human Resources Committee, to deal with all employee related matters including recruitment, training, remuneration, performance evaluation, succession planning, and measures for effective utilization of the employees of the Public Sector Company;
- d) Procurement Committee, to ensure transparency in procurement transactions and in dealing with the suppliers;
- e) Nomination Committee, to identify and recommend the candidates for Board for the consideration of shareholders after examining their skills and characteristics that are needed in such candidates.

The Board committees shall be chaired by non-executive directors and the majority of their members shall be independent. However, the independent directors in the committees shall not be less than their proportionate strength during the first four years of this notification. The existence of such committees shall not absolve the Board from its collective responsibility for all matters. Such committees shall have written terms of reference that define their duties, authority and composition, and shall report to the full Board. The minutes of their meetings shall be circulated to all Board members. The Board was requested to consider the matter and accord its approval for formulation of above mentioned committees along with their respective TORs.

# **AGENDA ITEM NO. 4**

# Presentation by CEO upon Company's profile & progress

In order to acquaint the Board Members with the wider scope of Company's working profile and progress, Mr. Fazullah Durrani Chief Executive Officer, gave an orientation presentation to the Board. He briefed the Board about Company's background, jurisdiction, organizational setup, customers profile, technical/commercial data and network comparison with other Discos. While briefing the Board about Company's performance, he apprised the Board that monthly line losses for May, 2016 have been decreased by 0.7% as compared to May, 2015, whereas, progressive line losses upto May, 2016 have been decreased by 0.9% as compared to previous year. MEPCO has achieved more than 100% recovery on average every month since he took over the charge of the Company. All the defective meters have been replaced against CP-90 and 218,018 Single Phase Meters, 11,450 Three Phase Meters, 639 MDI meters have been replaced during the current financial year. He also briefed the Board about load management plan during the Holy Month of Ramadan. While elaborating the detection charged and recovered during the current financial year, he apprised the Board that 81.22 MKWH units amounting to Rs. 959.27 M have been detected and 65.30 % of the charged amount has been recovered from the customers. Under new Ordinance, 790 cases were reported to Police department, out of which only 211 FIRs have been registered. The Members showed their concern for slow progress of registration of FIRs. Muhammad Suleyman Khan informed the Board that respective Inspector General of Police have appointed Focal Persons for different DISCOs on the request of the Ministry of Water and Power and opined that CEO should take up the matter with Ministry for appointment of Focal Person from Police department to vigorously follow the lodged FIRs or reported cases against theft of electricity. The Members also stressed to strengthen the Legal Department and nominate Focal Person from Company to keep liaison with Police Department. After detailed discussion, the Members opined to formulate a Legal Committee of the Board to scrutinize the Legal Matters of the Company. The Chair agreed with the proposal and formulated a Legal Committee



comprising of following Members to give its recommendations to the Board about Legal matters of the Company.

The Board instructed the Director Legal to give a presentation to the Board about the working and performance of his department. During the course of discussion, the Board instructed the CEO to ensure public awareness regarding newly established Complaint Redressal Cell (CRC) and online complaint system established at Ministry level. Mr. Khalid Masood Khan, showed his concern upon ratio of Damaging of Distribution Transformers. The Board instructed the CEO to develop a System Augmentation Program and give a presentation to the Procurement Committee about its roadmap and implementation. With above mentioned instructions, the Board showed its satisfaction on overall performance of the Company.

# **AGENDA ITEM NO.5**

To consider and accord approval for the following matter relating to procurement.

i) Approval for acceptance of tenders for Dismantling, Foundations Design, construction of Pile foundation, Tie Beams, Pile Caps, Erection, Stringing, Testing and commissioning of a portion of River crossing having a length of 2.435 km of 132-kv D/C Transmission line Sadigabad – Guddu (Break down work).

The agenda was presented by Chief Engineer (Development) PD (GSC) MEPCO. The Board was intimated that Executive Engineer (SS&T) Division MEPCO Multan vide letter # 10887-90 dated 22.01.2016, intimated that on 22.01.2016 at 0445 Hrs 132KV L-1 and L-2 at TPS Guddu tripped as a result of partial collapse of 03 No. towers No. 138 (special type tower), 139 and 140 (dead towers) of 132KV D/C Sadiqabad—Guddu Transmission Line. After checking of breakdown site, the matter was referred to Chief Engineer (Design) NTDC to depute their expert representative for providing appropriate solution to attend the breakdown work. On 27.01.2016, Deputy Director (Design) NTDC visited the site and brief recommendations were conveyed by Chief Engineer (Design) NTDC vide letter No. 1897-1900 dated 01.02.2016. Later on, Chief Engineer (Design) NTDC has approved an alternate profile vide plan tabling and profile No. PDW/TL-8135 and PDW/TL-8136 dated 22.03.2016 for captioned breakdown project. Tenders for the subject work were called and opened publicly in this office on 21.04.2016 by the Tender opening committee constituted vide Project Director (GSC) MEPCO office order No. 141/3891-93 dated 18.04.2016 in the presence of representatives of the firms. Five (05) Tenders were issued and only one (01) firm participated in bidding process and quoted the following rates in their bid for both Lot-1 & Lot-2.

The proposal mentioned in Lot-1 relates with the restoration / rehabilitation of original scope of work including dismantling, fabrication & erection of damaged portion of superstructure of existing towers along with stringing etc. whereas the proposal mentioned in Lot-2 relates with the rehabilitation of



captioned breakdown work with alternate proposal including insertion of 03 No. Towers in the river bed as per approved profile of Design NTDC Lahore etc. The bid evaluation committee in the BER has recommended the alternate proposal mentioned in Lot-II for attending the breakdown of captioned Transmission Line as the same Lot is long life scheme and by adopting this scheme there is less chances of break down on this portion of the Transmission Line. The Board was requested to accord approval for acceptance / approval of tender in respect of the only bidder M/S Mecons (Pvt) Ltd Lahore amounting to Rs. 345,610,000/- (Rupees: Three Hundred Forty Five Million Six Hundred and Ten Thousand Only) for Lot-2.

Upon the query of the Members about justification of quoted rates being reasonable, the PD (GSC) apprised the Board that the rates specifically for construction of 1500 mm dia pile foundation being major part of the works has been compared with contract executed at Jamshoro-Moro Section wherein rate for 1500 mm dia reinforced concrete pile comes to Rs. 238640/- per linear meter without casing, whereas, in the present rate M/s Mecons Lahore has quoted total rate of Rs. 250,000/- per linear meter with casing which is quite reasonable and competitive. The Board considered the matter at length and observed that the working paper presented to the Board is not properly prepared. The Members pointed out that the PPRA rules in case of single bidder have not been quoted and justification of rates quoted by the firm being reasonable has not been mentioned. Furthermore, comparison of specifications of the present under consideration work with that of the work executed at Jamshoro-Moro Section has not been provided in the presented working paper.

# Decision.

The Board after detailed discussion instructed the CE (Dev) to present the case after attending above mentioned observations.

ii. Approval for Engineering Consultancy Services including Construction Supervision for Dismantling, Foundations Design, Construction of Pile foundation, Tie Beams, Pile caps, Erection, Stringing, Testing and commissioning of a portion of River crossing having a length of 2.435 km of 132-kv D/C Transmission line Sadiqabad – Guddu (Break down work).

The agenda was presented by Chief Engineer (Development) MEPCO. The Board was apprised that Executive Engineer (SS&T) Division MEPCO Multan vide letter # 10887-90 dated 22.01.2016, informed that on 22.01.2016 at 0445Hrs L-1 and L-2 at TPS Guddu tripped as a result of partial collapse of 03 No. towers No. 138 (special type tower), 139 & 140 (dead towers) of 132KV D/C Sadiqabad – Guddu Transmission Line. Tenders for the said rehabilitation work were publicly called and opened on 21.04.2016. The contractor with integrated working at site needs continuous guidance and watch as MEPCO presently have No experience for supervision of construction of pile foundations in running water of river crossings and erection of JKD type tower as well as 220-KV EG Type tower etc. along with stringing for crossing of river spans. For this purpose, Project Director GSC MEPCO Multan vide letters dated 30.03.2016 has requested following 03 No. reputed firms to submit their financial proposals for providing the Engineering Consultancy Services including construction supervision for the captioned rehabilitation project.

M/S Accurate (Pvt) Ltd vide Letter No ACCU/MEPCO-IP/ 004 dated 11.05.2016 has explained that their discount rate was not conditional and is quite in accordance with tender Opening Clause IT-18, Sub Clause 18.3 & 18.4. M/S Creative Electronics\_vide Letter No C.E.Co/2016/447 dated 21.05.2016 has informed that they are lowest bidder in Lot-1, Lot-III & Lot-IV to this tender, all other bidders formed an illegal cartel and gave an identical price of (Rs. 1650/- of Lot 1, III & IV) whereas M/S Creative has quoted the rate of (Lot-1, Rs.1394) (Lot-III, Rs.1376) (Lot-IV, Rs.1358) the quoted prices of M/S Creative are 20% lower than the prices of cartel. In original bids all participant firms have made cartel/ pooled with slight variation in rates except M/S Creative who broke the combination/cartel, whereas, M/S Accurate (Pvt) Ltd added the 2<sup>nd</sup> envelope which is not accordance with PPRA Rule 36 (A) & tender condition IT.16.4, IT-17 and 17.11. Moreover, M/S Creative Electronics vide letter No C.E. Co/2016 /477 dated 09.06.2016 has further reduced the rates up to Rs.1240/- p.u of quoted Lots i.e (i, iii, iv). Similarly in the (Lot-ii) M/S PEL has voluntarily reduce the rate from 1650/-to 1240/- p.u. The Previous Purchase Rate Comparison is as under:-

Addl: Manager (TRW) MEPCO has informed that 30-35 Nos Average transformers of different capacities are being received in Reclamation Workshop and 18 Nos transformers of different capacity are being reclaimed on daily basis. To over come the situation in Hot Summer Season, this office has already made contract for repair of Normal / Regular Damaged Distribution Transformers with tender lowest firm M/S Swat Industry after adopting tendering process and as per approval of BOD MEPCO . Manager (MM) has allocated the 799 Nos 100& 200 kva transformers against Running on 2-phase, The defective transformers removed from site against above allocation are expected to be received in store and reclamation of which is required to meet up hot summer season demand which is not cover up in already made agreement. Beside above capacity of transformers, 10 & 15kva defective transformers are also lying in Regional Store Multan for repair and no contract is awarded for repair of these transformers. In case of Issuance of new transformers for restoration of supply in Hot Summer Season to avoid public protest will result in tremendous increase of the maintenance Head expenditure, to meet up demand of field formations regarding reclamation & to avoid issuance of new transformers for restoration of supply of effected area, the tender was floated. The Board was informed that Punjab Housing & Town Planning Agency (PHATA), Sub Region Bahawal Pur has developed a 03-Marla housing scheme at Chishtian for poor people and submitted the design for external electrification of said Housing Scheme through their Consultant M/S Anwar Consultant Faisalabad. Total ultimate demand of the scheme worked out 1958.96 KW or 2304.66 KVA equivalents to 121 Amps. Electrification of the scheme is proposed through 01 No. 11KV independent feeder thus the total project cost worked out is Rs. 47.608 Million (Electrification Cost Rs. 42.370 Million, Grid Sharing Cost Rs. 5.237 Million & Design Vetting Charges Rs. 0.635 Million). Furthermore, the Board was apprised that the Deputy Director PHATA vide letter No. 967 dated 30-05-2016 has requested that a provisional demand notice amounting to Rs. 20 Million may kindly be issued so that funds released by Govt. of Punjab, HUD & PHED may be utilized. The Board was requested to accord administrative approval for sanction of External electrification cost to the tune of Rs. 47.608 Million and issuance of provisional demand notice amounting to Rs. 20 Million as per request of Deputy Director PHATA.

#### Decision

The Board accorded its administrative approval for sanction of external electrification cost to the tune of Rs. 47.608 Million in respect of "03-Marla" Housing Scheme situated at Chak # 41-F, Chishtian under Punjab Housing & Town Planning Agency (PHATA) and issuance of provisional demand notice amounting to Rs. 20 Million as per request of Deputy Director PHATA.
