AGENDA ITEM NO.4

To consider & approve syndicated Islamic term finance facility of up to Rs. 600 Billion for Power Holding (Private) Limited.

The agenda was presented by the D.G. (HR & Admin) & Finance Director. The Board was apprised that Government of Pakistan, Ministry of Energy through its wholly owned subsidiary Power Holding Private Limited (PHPL) is in process of arranging Shariah Compliant Islamic Finance Facility in the range of upto PKR 600 BN to settle the energy sector circular debt. The Islamic Finance Facility will be raised using Islamic Syndicate Facility or issuance of Sukuk(s) on Diminishing Musharaka / Ijarah structure (sale and lease back) basis for 10 years tenure using Assets included but not limited to Land, Building and Plants owned by the Company. The Section Officer, Ministry of Energy (Power Division) Govt. of Pakistan Islamabad vide letter dated 10.12.2018 has forwarded a copy of letter dated 07.12.2018 issued by Power Holding (Pvt) Ltd. (PHPL) on the subject matter that desired MEPCO to provide the following information / approval of the Board of Directors to PHPL for onward submission to the syndicate:-

- (i) Board Resolution authorizing PHPL to use and sell the transaction assets and utilize the sale proceeds for the purpose of raising finance under Islamic Finance Facility (in one or multiple tranches) and creation of required security charge on the assets in favour of Islamic Finance Facility providers.
- (ii) NOC / consent / permission from the respective companies / entities in favour of Power Holding (Private) Limited (Obligor) to sell undivided share in the assets under collateral to the financers.
- (iii) In-house clean legal opinion of the transaction assets.
- (iv) Clean title documents of the transaction assets.

The above requisite information / documents, for which prescribed draft provided by Ministry, has been prepared.

- (i) In house Legal Opinion
- (ii) Legal opinion, as desired, from Independent Lawyer on transaction and assets
- (iii) NOC
- (iv) Title documents of the transaction assets.

Based on the request of Ministry of Energy, to facilitate the Islamic Finance Facility, the Board was requested to accord its approval for the followings:-

- 1) To authorize Power Holding Private Limited (PHPL), a wholly owned subsidiary of Ministry of Power Government of Pakistan, to use & sell the Transaction Assets and utilize the Sale Proceed thereafter for the purpose of raising financing under Islamic Finance Facility (in one or multiple tranches) in a manner as PHPL deems fit.
- 2) To authorize Company Secretary MEPCO BOD to provide all required permissions / NOC in favour of PHPL to enable PHPL to execute the above mentioned Islamic Finance Facility transaction and to execute any transaction document required in this regard.
- 3) To allow MEPCO that it will hold the Legal Title of these assets in Trust as Trustee or / and Title Agent on behalf of the Islamic Financiers and will execute any required document in this regard after the execution of sale transaction of Transaction Assets between PHPL and the Islamic Financiers.
- 4) To authorize PHPL to create all required security interest / lien / mortgage / charge / hypothecation on the Transaction Assets in favour of Islamic Finance Facility providers and authorize the Company to execute all such transaction & security documents as required by PHPL and Islamic Finance Facility Providers. The Board also authorizes the Company to hand over the original title documents related to Transaction Asset to PHPL for the above transaction, if required for the purpose of the transaction.

- 5) Until the maturity of the above transaction, MEPCO cannot sell these Transaction Assets and nor it will create any sort of security interest / lien / hypothecation / charge or mortgage of any nature whatsoever in favor any third party over these Transaction Assets nor enter into any financing transaction using the Transaction Assets.
- 6) MEPCO will timely provide details of all major maintenance costs and other structural repair details along with evidences of Transaction Assets to PHPL and Islamic Finance Facility Providers as and when required.
- 7) MEPCO will disclose in its Annual Accounts / Reports with an appropriate note / disclosure that it is holding the title of the Transaction Assets in Trust as Trustee or / and Title Agent, as the case may be, on behalf of the Islamic Finance Facility Providers.
- 8) At the maturity of the transaction, PHPL will purchase the Transaction Assets from Islamic Finance Facility Providers and pass over the clean title back to the Company.
- 9) The board also confirms that MEPCO is the legal owener Assets & hold clean legal title of the Transaction Assets free from any nature whatsoever.
- 10) The In-house clean legal opinion provided by Director (Legal) MEPCO / Legal Advisor MEPCO (Annex-"C") in respect of transaction assets is allowed to be conveyed to Ministry of Energy (Power Division) Govt. of Pakistan Islamabad.
- 11) To provide list of title documents of the transaction Assets of MEPCO to Ministry of Energy (Power Division) Govt. of Pakistan Islamabad.

The Board was also apprised that MEPCO management its letter 66022-23 dated 21.12.2018 has informed Section Officer (PF), Ministry of energy (Power Division) Islamabad that five (05) properties are not under the title of MEPCO.

The Board was further intimated that legal opinion from an independent lawyer was also obtained in this regard.

Board members had a consensus that the matter is of high signifacnace having legal and financial implications.

The Board discussed the matter at length and appreciated the efforts of Government of Pakistan in arranging Islamic Finance Facility for resolution of Power Sector Debt. However, the Board observed that documents received from the Ministry relating to this matter do not depict clarity on the modalities of the proposed transaction. The comprehensive role, responsibilities, risks and financial liabilities of MEPCO with regards to debt servicing including the transactions expenses and cot of financing have not been clarified. It is not clear that whether it will have any adverse impact on the distribution margin of the Company or otherwise, who will pay propert transfer/capital gain taxes and othe related levies. All members had a unanimous opinions that the observations of the Board need clarification before proceeding further as required by the ministry of energy (Power Division) Finaly, the Board directed the

From the above rate comparison of quoted rates with MEPCO previous purchase rates, it is obvious that the rates offered by the firm in current MEPCO tender are 13.68% higher from previous purchase rate while LME Steel has been increased 36.22% and US \$ Exchange Rate has been increased 18.46 % w.r.t current tender opening date and 32.31 % increase from current exchange rate. The approval for procurement amounting to Rs. 75,276,631 /- (Pak Rupees; Seventy Five Million, Two Hundred Seventy Six Thousand, Six Hundred and Thirty One only) falls under the competency of Chief Executive Officer MEPCO but due to participation of two bidders its competency falls to the next higher authority i.e. MEPCO Board of Director as per NTDC Book of Financial Power-2007 Section-IV Clause - 4.2 for placing LOI / P.O. in favor of M/s Pakistan Engineering Company, Lahore amounting to PKR 75,276,631/- (excluding GST & SED) being lowest evaluated responsive bidder in national competitive bidding. The Store Balance of Extensions for ZM Towers is Nil and Project Director GSC MEPCO is pressing hard for allocation of material to complete the 23-No. Transmission Lines. The Procurement Committee was requested to recommend the case for Board's consideration and approval. The Board was apprised that Procurement Committee of the Board has recommended this case for Board's approval with the direction to provide the rate comparison with other DISCOs. The CE (Dev) apprised the Board that all DISCOs were requested to give their rate but only HESCO has given its last purchase rate which is has been mentioned in working paper.
